



Member's Agreement:

LJFL RESERVES THE RIGHT TO DENY ACCEPTANCE OF ANY APPLICATION

1. I/We the parent(s)/guardian(s) of the player named above do hereby give my/our approval for all participation in the Livermore Junior Football League activities for the current season.
2. I/We assume all risks and hazards to this participation for any claims arising out of injury to my/our child, including, but not limited to, transportation to and from such activities.
3. I/We hereby waive, release, absolve, indemnify and agree to hold harmless the League, officers, directors, teams, organizers, sponsors, managers, coaches, supervisors, participants, persons providing transportation and any organization with which LJFL may be affiliated ("Releasees") with respect to any and all claims, injury, disability, death, or loss or damage to person or property, whether arising from the negligence of the Releasees or otherwise.
4. I/We understand that we are responsible for carrying primary medical insurance and that the League carries only secondary insurance. Physical and medical release forms are required before participation can begin.
5. I/We will furnish a birth certificate for my child if requested. Required for all first time players
6. I/We understand that my/our child will not be assigned to a team without full registration payment.
7. I/We understand that information provided to the league for registration is kept private. Contact information is distributed only to the head coach once your child is placed on a team. The head coach may distribute contact information within the families of a team for communicating important team information.
8. I/We understand disciplinary problems involving my/our child can lead to removal from team and possible loss of registration fee.
9. I/We agree to abide by LJFL's Parent Code of Conduct and its bylaws. I/We have read LJFL's Parent Code of Conduct and its bylaws and understand our obligations as a parent and as a role model for children.

League Photos:

LJFL at times may post random action photos/videos of game days and LJFL events on the league website. Photos/videos on the internet can be seen by people all over the world. By registering with LJFL, you are granting permission to LJFL to use photos/videos that may include your child. At any time, you can contact LJFL to remove a website photo that includes your child or withdraw your permission to post photos/video of your child by sending an email to the EveryonePlays@ljfl.org. Include your child's name, team and jersey number in the email.

Parents Code of Conduct:

1. I agree to encourage an environment that is positive, supportive, and healthy--both physically and mentally--while participants learn the sport of football/cheerleading.
2. I agree that it is a privilege, not a right, for my child to participate with the Livermore Junior Football League
3. I agree to encourage sportsmanship and fair play that are essential to all sports and activities
4. I agree that because children learn by example, parents, coaches, and volunteers need to exemplify the highest level of conduct, sportsmanship, and fair play. Personal conduct at games, practices, and other team events must be above reproach and represent the highest standards of morality and sportsmanship.
5. I agree to support the coaches and referees. I agree to refrain from directing any abusive or profane language toward the coaches, players, umpires, or anyone associated with LJFL. I also agree to communicate any constructive criticism in a private, non-confrontational manner.
6. I agree to not instigate or participate in any confrontations in front of the children. Disagreements will be handled calmly in the absence of the children.
7. I agree to refrain from alcohol consumption or tobacco use during practices or games.
8. I agree that the overall objective is to provide a fun, sports oriented experience for our children.
